Matters Arising	<p><b>Highways</b> –The proposals to introduce the 20mph and 40mph speed limits have been issued to statutory consultees with the deadline for reply set for 10<sup>th</sup> June 2016. If no objections are received the draft order will be published.</p> <p>It was confirmed that patching work had been undertaken.</p> <p><b>Bus Shelters</b> – Councillors confirmed that the necessary repairs should be undertaken.</p> <p><b>Benches</b> – Further information regarding an alternative supplier was presented. Following discussions it was decided to order the Glasdon bench as discussed previously– proposal by WT, seconded by DD.</p> <p><b>Penbompren Wilderness</b> – Further information was tabled regarding insurance, risk assessment and liability. Concerns were expressed regarding ongoing maintenance obligations. It was decided to postpone the decision pending further information.</p> <p><b>Skanda Vale</b> – The ongoing issues of cars travelling to Skanda Vale were discussed.
