Introduction and Context

Llanpumsaint is a small rural community comprising approximately 730 residents (2021 Census). The community covers 26 km² with a population density of 28 people/km². The land is used mainly as grazing land for sheep, beef and dairy cattle or cut for silage; there are a handful of hay meadows. The Afon Gwili runs through the village, with five tributaries and a small sewage works, eventually joining the Afon Tywi near Carmarthen. There are some private woodlands and a network of hedges and verges, with minor pockets of land at road junctions. There are a few public footpaths, some of which are not very accessible (overgrown, locked gates and styles). The dis-used railway track of the old Gwili railway, currently owned by the Gwili Steam Railway, runs into the village from the south west and is navigable on foot. To the north east, the old railway line and goods yard forms the allotments. Beyond that, the land is now privately owned.

The community benefits from two independent charities responsible for running the village hall and the village park. The latter includes a football pitch, children's play area, tennis court and meadow. Both organisations often receive an annual small grant from the Community Council. Carmarthenshire County Council is responsible for the allotments. There is a Welsh-medium village primary school with around 30 pupils. The village produces a bi-lingual magazine every three months which is hand-delivered to all households.

The Community Council has a modest portfolio of assets: Ty Hers (a single room which used to house the horse-drawn hearse and is now rented out as a storage space), four bus shelters, five seats, two out-of-use telephone boxes and the streetlights. The annual precept for 2025/26 was £11,780. The Council engages with other groups in the village to promote biodiversity since it has limited opportunities to act independently.
